

INSTRUCTIONS FOR FILLING OUT THE APPLICATION FOR THE PROVISION OF TRANSMISSION SERVICES

1. The number of the application for the provision of gas transmission service, hereinafter the Application – to be filled out by Gas Transmission Operator GAZ-SYSTEM S.A., hereinafter the TSO (Transmission System Operator).
2. Date of Application submission to the TSO – to be filled out by the TSO.
3. Please write down full name of the entity that submits the Application, hereinafter the Applicant.
4. Please write down the Court Registration Number (KRS) of the Applicant.
5. Please write down the REGON statistical number of the Applicant.
6. Please write down the Tax Identification Number (NIP) of the Applicant.
7. Please write down the Applicant's registered address in the following boxes (country, postal code, city, street, building number).
8. Please check this box if the correspondence address of the Applicant is different than the registered address, and provide the details in the following boxes (country, postal code, city, street, building number).
9. Please check this box in case when the Applicant is a final customer eligible to choose the supplier of gaseous fuel.
10. up to 16. Please write down the first name, surname and other necessary details of the representative of the Applicant authorised to contact the TSO with regard to the submitted application.
17. up to 23. Please write down the first name, surname and other necessary details of the second representative of the Applicant authorised to contact the TSO with regard to the submitted application.
24. Please check this box in case when the Applicant encloses the required current extract from the National Court Register (KRS) or a copy of entry into the register of business activity to the application.
25. Please check this box in case when the Applicant encloses the required certificate of the assignment of REGON statistical number to the application.
26. Please check the box in case when the Applicant encloses the required NIP number assignment document to the application.
27. Please check the box in case when the Applicant enclosed documents confirming the right of the individuals signing the forms to represent the Applicant and incur liabilities on its behalf and such right does not result from the extract from the National Court Register (KRS) or from the entry into the register of business activity.
28. Please check this box in case when the Applicant is an energy company and holds a licence for the transmission of gaseous fuel, and write down its number in the next box.
29. Please check this box in case when the Applicant is an energy company and holds a licence for the distribution of gaseous fuel, and write down its number in the next box.
30. Please check this box in case when the Applicant is an energy company and holds a licence for the trade and supply of gaseous fuel in the territory of the Republic of Poland, and write down its number in the next box.
31. Please check this box in case when the Applicant is an energy company and holds a licence for the storage of gaseous fuel, and write down its number in the next box.
32. Please check this box in case when the Applicant is an energy company and holds a licence for the trade and supply of gaseous fuel outside the territory of the Republic of Poland, and write down its number in the next box.
33. Please check this box in case when the Applicant is an energy company and holds a licence in respect of the storage and re-gasification of LNG, and write down its number in the next box.
34. Please check the box in case when the Applicant, enclosed a Power of Attorney for auctions.
35. Please list other documents enclosed to the application, if not mentioned above.
