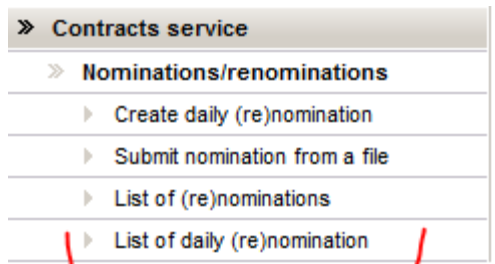


Nomination file export from IES in XML format

After log into IES, you should choose menu Contracts service/List of daily renomination



On displayed list of nominations you should choose requested nomination and click on nomination preview icon in Actions column:

Then detail information about this nomination is displayed. Choose “XML” button which is located in the lower right part of the screen.

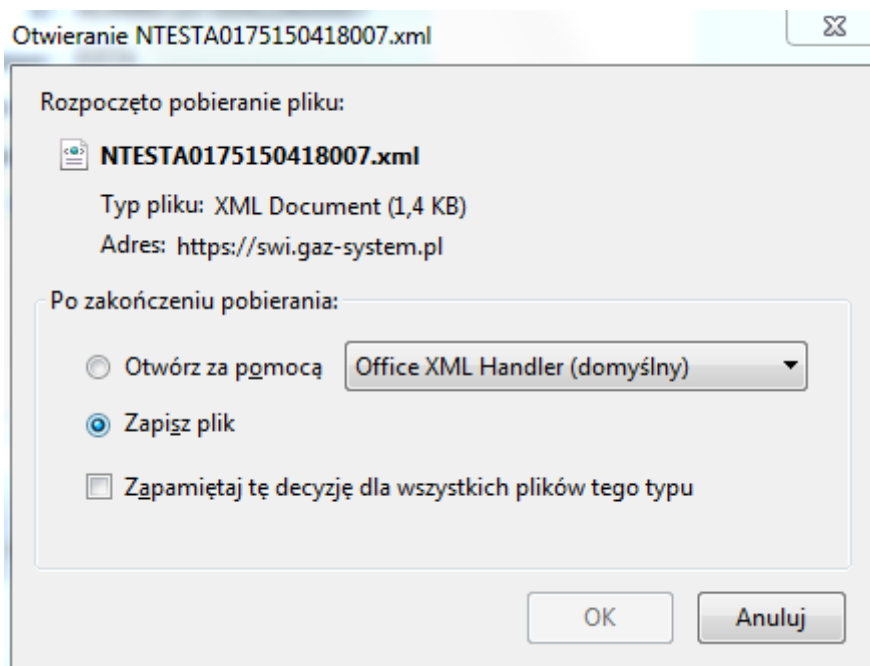
