APPLICATION FORMS FOR PROVISION OF THE TRANSMISSION SERVICE

We kindly inform, that since 1st June 2016 according to the arrangements in current version of the Transmission Network Code (v25) (TNC), the rules of application process for transmission contract, capacity allocation (PP) and transmission ability allocation (PZ) have changed. According to the arrangements in TNC the submission of above-mentioned applications and their analysis process shall take place by IES (Information Exchange System). For this purpose is necessary to submit an [appropriate power of attorney](#), signed by the representative person in your organization, for the persons authorized to represent your organization in the above-mentioned procedures via the IES.
