In connection with the approval of "The Tariff for Gas Transmission Services No. 12" on 1st June 2018 by the President of the Energy Regulatory Office, please be informed that pursuant to Article 32 of the Commission Regulation (EU) 2017/460 of 16th March 2017 establishing a network code on harmonized transmission tariff structures for gas, the Gas Transmission Operator GAZ-SYSTEM S.A. has hereby published tariff rates (reserve prices) on the [www.gaz-system.pl](http://www.gaz-system.pl) website, which will apply from January 1st, 2019.

The Tariff for Gas Transmission Services No. 12 has been approved to be applicable up to 31st December 2019.
